### GENERAL

### MEMBERSHIP (Categories)

Membership is open in the following categories:

- 1. Patron Member** (Indian Companies / Firms / Body Corporate / Business Units subject to fulfilling various criteria as may be laid down by National Council from time to time.)
- 2. Corporate Member** (Indian Companies / Firms / Body Corporate / Business Units subject to fulfilling various criteria as may be laid down by National Council from time to time.)
- 3. Affiliate Member** (Companies providing equipment / services to construction companies i.e. suppliers, vendors, construction equipment manufacturers, etc. subject to fulfilling various criteria as may be laid down by National Council from time to time.)
- 4. Associate Member** (Subject to fulfilling various criteria as may be laid down by National Council from time to time, the following entities shall be considered as Associate Members:
  - Foreign companies / organizations operating in India but not registered in India
  - Representative offices of foreign companies operating in India as Liaison Offices
  - Any Association operating in India whose aims and objects are similar or identical to those of Construction Federation of India)
- 5. Institutional Member** (Educational institutions, IT institutions, Research & Development institutions, all India Professional institutes/Organizations/Boards relating to construction/other industry, etc.)

### MEMBERSHIP FEE

Members will have to pay annual fee as elaborated below. For new members, the annual fee will be payable along with the application for admission.
